The aim of the Foundation's statutory activities specified in the act of foundation, as well as the statute is:

- -Promote Activities of rehabilitation of persons with disabilities
- Activation of healthy people, and especially young people to rehabilitation activities.
- Initiating and supporting research activities and popular in the theory and practice of rehabilitation processes of people disabled.

The Foundation realizes its statutory objectives by:

- Material and financial assistance for people with disabilities.
- To support and maintain contact both with people with disabilities, as well as with their families.
- Facilitate social activity of people with disabilities, including the elimination of prejudices against persons with disabilities.
- Attracting sponsors of occasional and permanent.
- Collaborate with objects that operate convergent with the objectives foundations.
- Collaborate with individuals showing interest objectives foundations.
- Establishment of sub-accounts to help people with disabilities and their families raising funds for medical treatment, rehabilitation and purchase of equipment.

By the end of 2010, the Foundation has provided 1,564 sub-accounts.

We actively participated and supported the Wielka Orkiestra Świtecznej Pomocy.

Between 12.06-18.06 we organized for our students with the Commune Ryman tour which was attended by 55 people, pupils, guardians, volunteers. The purpose of our trip was to attend a Festival

"Zaczarowana Piosenka" in Krakow, and a meeting with the President of the Foundation "Mimo wszystko" Anna Dymna. Participation in the Spartakiada for the disabled. Sightseeing sights of Krakow. Then we went to Zakopane, where participants tours defeated the barrier of fear driving the cable car to Kasprowy. Related feelings and sensations experienced riding a chairlift at Gubałówka.

Throughout the year, our beneficiaries used free of classes therapeutic and rehabilitation carried out by the therapist and rehabilitator. Care was extended to 27 people with mental disabilities in considerable extent, moderate and light in the classes took an active part 9 people. Classes and rehabilitation were conducted three times a week (Monday, Wednesday and Friday) between the hours of 15 to 18.

Keeping therapeutic activities for both group and individual improves the impaired body functions charges.

These classes help raise the level of psychomotor skills intellectual disabilities and support the previous behaviour social and learn new ones.

Each person realized the rehabilitation of the individual as well as group therapy.

October 18 began construction of offices and the center of the foundation.

December 6 organized along with employees of the Municipal Office and School Christmas Party.
