### 1.Opis działalności pożytku publicznego

<p>1.1 Description of the main activities undertaken by the organization</p>	<p>Their statutory activities of public benefit Foundation in 2012. The Foundation "Słoneczko" implemented by 3191 sub-service to facilitate people with disabilities and their families raising funds for medical treatment, rehabilitation and purchase of equipment. The Foundation conducted free of charge account maintenance, do not charge a commission or charges from donors or foundations. All the funds on sub-accounts as a whole remained at their disposal. These funds are used by them primarily on the rehabilitation, expensive treatments, purchase of rehabilitation equipment following submission of appropriate accounting documents - invoices, bills. Foundation staff were always available to our pupils and their families by helping them and facilitating social activity.</p> <p>A very important event undertaken by the Foundation in the context of public benefit activities was the date 07.08.2012r. in which completed the construction of offices and rehabilitation center. The resort apart from offices there are 19 rooms accommodated for the disabled, a large hall and rooms for therapeutic rehabilitation.</p> <p>As part of a wide-ranging statutory public benefit activities run with the help of the Municipal Office in Rymaniu free therapeutic and rehabilitation activities for pupils. Care are covered by 27 people with mental disabilities to a considerable or moderate and light. The classes took an active part 11 people, with classes held daily. Teaching therapeutic and rehabilitative both group and individual streamline impaired body functions, increase the level of psychomotor skills of people with intellectual disabilities, support existing social behaviors and learn new ones.</p> <p>For the second time we organized the Small Festival "Integration You and Me" which took place on September 4 at. 18.00 in the newly built rehabilitation Foundation. The event was attended charges Foundation, patients Zabajka rehabilitation center, proteges Occupational Therapy Workshops in Złotowo, 4<sup>th</sup> Scout group "Wykrzyknik" of Zakrzew and guests. It was a special day for us due to the new location. Our little festival started with the tour of the resort. In our area there is a small zoo, you can see wild boar, deer, goats, ostriches and even a donkey. However, the biggest interest was a herd of beautiful horses that are used for hippotherapy. We held a small demonstration of rehabilitation equipment, new achievements rehabilitation techniques. Time projection. Our mentee, and also an excellent bellwether Tobiasz Carewicz invited everyone on the film "The dream of the wild west.". After the first movie we all wanted to be actors. The second film "Dirty Words" is a story about Tourette syndrome, but also about what happens to the life of the hero in various situations. Excellent atmosphere, lots of fun, smile, sing along with the scouts give to all the positive energy. This year's festival with disabilities showed that everyone can fulfill your dreams, pursue their goals. "They do not like to be called disabled. They define themselves fit differently. ". Also they love to have daily problems, sorrows and joys.</p> <p>With the cooperation of volunteers organized a charity project "The Pursuit of Happiness". The idea of charity project "in the pursuit of happiness" was born September 25, 2012. On this trainee solicitor Thomas Pogon was drawn from 303.450 (three hundred and three thousand four hundred and fifty) requests to participate in the marathon, "Tokyo Marathon 2013", which took place 24 February 2013. in Tokyo.</p> <p>The aim of the project was to help those in need through physical activity.</p> <p style="text-align: center;">We have worked with other organizations and institutions which directly or indirectly affect the lives of people with disabilities and their families.</p>
